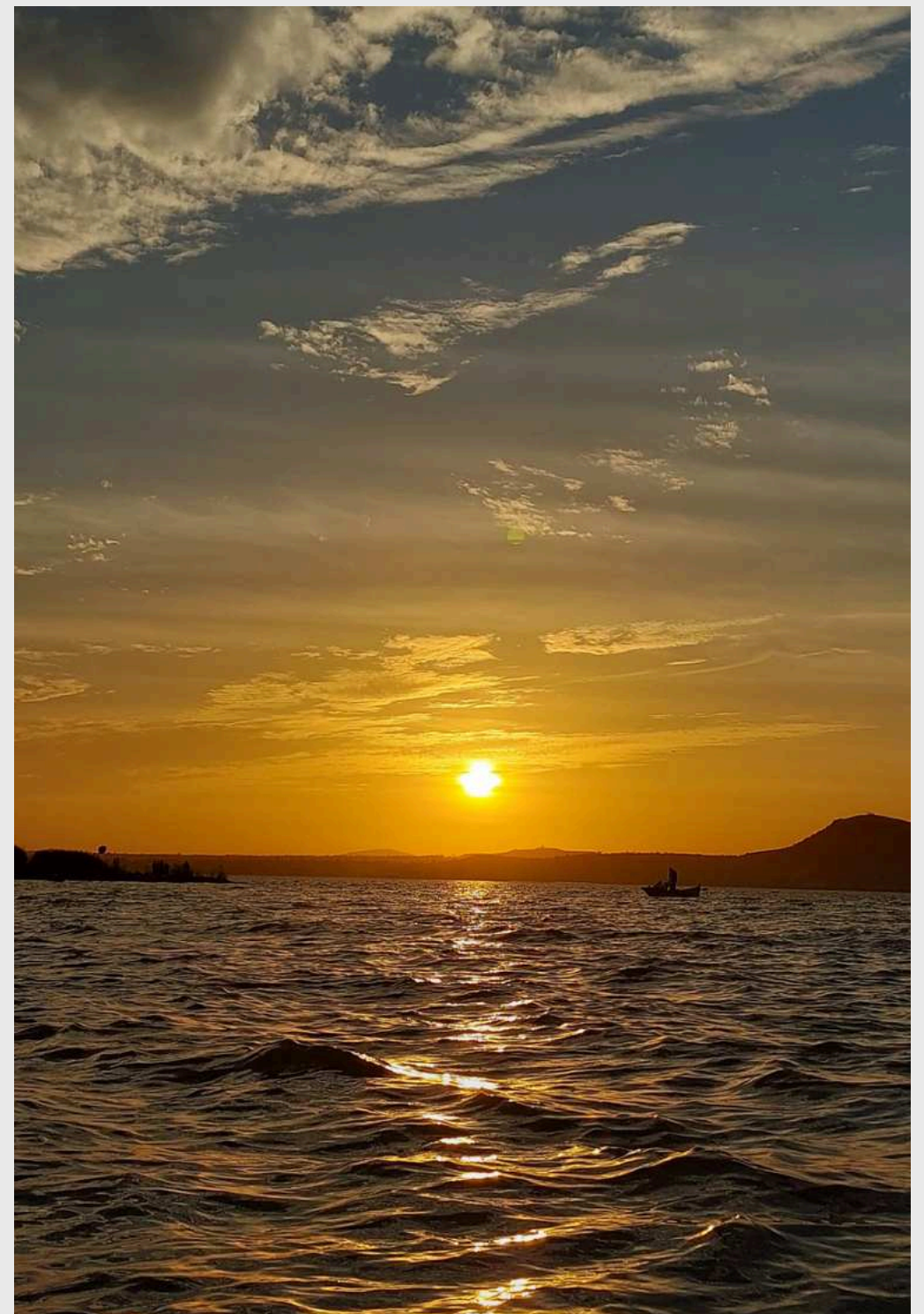
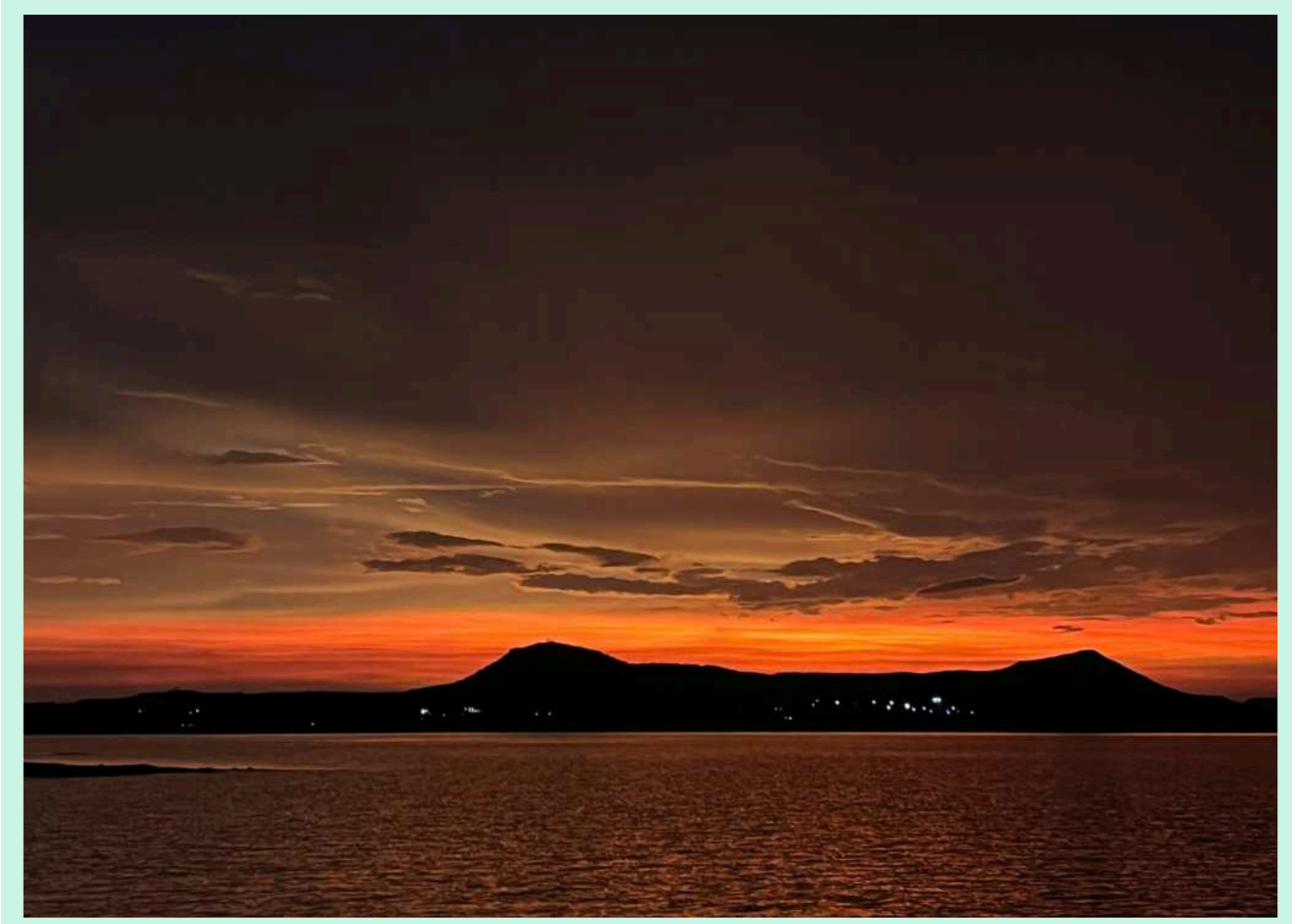

US Treasuries: Still a Safe Haven or a Risk Repriced?

US government bonds and the dollar have been the ultimate “safe haven” for global investors. In times of turmoil, capital would flee riskier assets and pour into US Treasuries, pushing yields down and reinforcing America’s reputation as the world’s financial anchor. But in 2025, that narrative is facing its toughest challenge in decades. With US 10-year Treasury yields hovering around 4.3%—nearly double the average of the previous five years—many are asking: Does the US still deserve its safe haven crown?

Treasuries: The Traditional Barometer of Trust

US Treasuries have long been the gold standard for safety. They are backed by the “full faith and credit” of the US government, trade in the world’s deepest bond market, and serve as the benchmark for global borrowing costs. When investors trust the US, they buy Treasuries—yields fall. When they worry, yields rise.

But this year, something unusual is happening. Despite global uncertainty, US Treasury yields remain elevated, and at times, have even spiked during market stress. This is a sharp break from the past, when crises would reliably send yields lower.



Why Are Yields So High?

Several forces are driving this shift:

- **Persistent Inflation**: US inflation has been stubbornly above the Federal Reserve’s 2% target, eroding confidence that price stability will return soon. Investors now demand higher yields to compensate for this risk.
- **Fed’s “Higher for Longer” Policy**: The Federal Reserve is signaling that interest rates will remain elevated, with little urgency to cut, in order to keep inflation in check.
- **Ballooning US Deficits**: The US is running fiscal deficits above \$1.9 trillion, pushing the national debt to over 140% of GDP. This means more bonds are flooding the market, and investors want higher returns for absorbing this supply.
- **Term Premium Returns**: With uncertainty about US fiscal policy and inflation, investors are demanding extra yield (the “term premium”) for holding long-term Treasuries.

What Does This Mean for the US Safe Haven Status?

Traditionally, when risk rises, US assets shine. But in 2025, the picture is more complicated:

- **Volatility Replacing Stability:** In recent months, US stocks, bonds, and even the dollar have seen simultaneous sell-offs—an unusual pattern signaling growing investor anxiety over American economic leadership and policy direction.
- **Global Diversification:** Central banks and investors are increasingly diversifying into gold, German bunds, and even alternative currencies. Gold, for example, has surged to record highs, with some forecasts expecting it to approach \$4,000/oz by 2026. This reflects a search for safety outside the US dollar system.
- **De-Dollarization Trend:** While the dollar still dominates global trade, there is a slow but steady move by some countries to reduce reliance on the greenback, especially among BRICS and Asian economies.

Are Treasuries Still Safe?

Despite the turbulence, US Treasuries remain unique in several respects:

- **Unmatched Liquidity:** No other bond market comes close to the size and liquidity of US Treasuries. Even during sell-offs, they remain the easiest asset to buy or sell in size.
- **Global Reserve Role:** Central banks worldwide continue to hold large amounts of Treasuries for reserves, and foreign demand, though volatile, remains significant.
- **Fed Backstop:** The Federal Reserve has signaled it will intervene if market functioning is threatened, providing a safety net that few other markets can match.

However, the “risk-free” label is being re-priced. Investors are now factoring in US political gridlock, fiscal sustainability concerns, and the possibility that America’s economic dominance may not be as unassailable as before.

What Do Current Trends Suggest About the Future?

- **More Volatility:** The traditional flight-to-safety into Treasuries during crises may become less reliable. Investors may split their “safe” allocations between US assets, gold, and other alternatives.
- **Higher Borrowing Costs:** Elevated yields mean higher interest costs for the US government, potentially worsening fiscal challenges and making Treasuries more sensitive to global risk appetite.
- **A Gradual Shift, Not a Sudden Exit:** There’s no immediate replacement for US Treasuries, but the world is slowly hedging its bets, diversifying reserves, and questioning old assumptions.

Conclusion: A Safe Haven, But Not What It Was

The US remains a cornerstone of global finance, but its safe haven status is no longer absolute. Rising yields, fiscal uncertainty, and shifting global dynamics mean Treasuries are behaving less like a “risk free” asset and more like just another investment—subject to the same doubts and pressures as everything else.

For investors, policymakers, and students of finance, the message is clear: Don’t take the old rules for granted. The US is still a safe haven, but the world is watching—and hedging—like never before.
